#### **Please read before completing the Form.**

The Bermuda Sailors' Home ("BSH") is a registered charity incorporated under the laws of Bermuda, whose purpose is "to provide recreation centres and homes for and the promotion of the happiness and wellbeing of all seafarers".

Members of the BSH are entitled to use the facilities of the BSH in Hamilton, which is known as the "Mariners Club". Through the use of the Club, Members are supporting the charitable purpose of the BSH. In return for cost of the membership, the benefits include:

- Full access to the Sailors Home facilities:
  - Bar
  - Games room
  - ½ price rental of the hall 4 times per year for social functions
- Free use of the Banyard Room for board meetings
- ½ price rental of the hall twice per year for private functions

The completed Form must be handed in at the office along with the first year's dues.

A receipt will be issued for your dues which will enable you to use the facilities of the "Mariners Club".

#### ***At this point we wish to mention a few points from our Bye-laws and Constitution.***

1. All guests of Members must be signed in and the Members must be in the Club whilst their guests are in the premises. Guests cannot be signed in more than 3 times per month (liquor license regulations).
2. The Constitution allows for termination of membership in cases of unsociable behaviour.
3. Children are welcome, however, parents are expected to keep them under control and any child under the age of 18 is not allowed at the bar.
4. No persons shall enter the Club premises unless suitably and cleanly dressed and at all times will be expected to conduct themselves in a civil and dignified manner.
5. In the event the Club premises are crowded by an influx of visiting seafarers, Members may be requested by the Manager to leave the premises in order that our primary objectives may be fulfilled.

It is hoped that Members will offer their services to the Club by serving as committee members. We believe that you will find membership in our Club worthwhile and enjoyable. We hope that you will use the Club's facilities frequently and attend our entertainment functions while never forgetting the primary purpose of our Club. We hope that you will take the time to talk to visiting seafarers.
